



RELEASE, WAIVER OF LIABILITY AND AGREEMENT TO PARTICIPATE

I, _____, wish to participate in the Fit Girls Sport Day activity which shall encompass a yoga practice at Bell MTS Place on Saturday, March 9, 2019 (the "Activity").

In consideration of being permitted to participate in any way in the Activity, I, for myself and for my personal representatives, assigns, heirs and next of kin, provide as follows:

I fully understand that the Activity may involve risks and dangers of serious injury, including but not limited to permanent disability, paralysis and death. There may be other risks and social and economic losses. I fully accept and assume all such risks and responsibility for losses, costs and damages incurred as a result of my participation in the Activity.

I, on my own behalf, and on behalf of my heirs, legal personal representatives, successors and assigns (collectively, the "Releasor"), hereby irrevocably and unconditionally release and forever discharge Winnipeg Jets Hockey Club Limited Partnership, Winnipeg Jets Hockey Club Inc., The True North Entertainment Complex Limited Partnership, True North Sports & Entertainment Limited, TN Arena Limited Partnership, TN Arena Inc. I grant True North and/or the sponsor(s) of the Activity the unrestricted right to produce, reproduce, publish, broadcast, communicate by telecommunication, exhibit, distribute, adapt or otherwise use or re-use my name and any statements, endorsements, biographical information, voice recordings, photographs and likeness to photographs, videotapes, film or sound recordings provided for, stemming from, or obtained or taken in relation to, my participation in the Activity for any and all advertising or promotional purposes (including but not limited to publication and/or broadcast in media) without further compensation or permission.

I acknowledge the decisions of True North and the sponsor of the Promotional Activity are final with respect to all aspects of the Promotional Activity, including but not limited to eligibility of contestants, rules and the awarding of prize(s).

I HAVE READ THIS RELEASE, WAIVER OF LIABILITY AND AGREEMENT TO PARTICIPATE AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS RELEASE, WAIVER OF LIABILITY AND AGREEMENT TO PARTICIPATE IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
